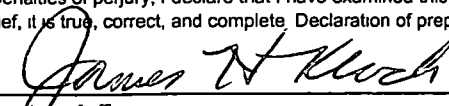

In the three-year period from 2007 through 2009, Tri-State Ambulance, Inc. achieved an impressive 47.7% discharge from hospital cardiac arrest survival rate. Tri-State Ambulance maintains a high level of skill proficiency through an aggressive Continuous Quality Improvement program. We have two paramedics on every ambulance so that the two can work simultaneously and collaborate with one another on the clinical needs of the patient. In 2009, Tri-State Ambulance continued to operate efficiently and effectively through the addition of demand analysis studies and by implementing dynamic staffing changes.
