### **Part III Oaklawn's mission statement**

The *Oaklawn Harmony Centre Inc.* shall build upon the quality of the community for the purpose of creating seamless services by strengthening partnership, and increasing collaboration among non-profit organizations addressing issues of poverty faced by individuals who live and work in the community. To this end, Oaklawn Harmony Centre will:

- Lead in the development and implementation of collaborative programs that increase self-sufficiency of families with young children (Head Start anchor) in West Central Wisconsin.
- Provide staff and systems (to nonprofit) organizations to streamline and analyze current services and determine how additional people and needs can be served
- Assist non-profit organizations in obtaining funds for positive, high impact programs and service using grant writing and private donors
- Provide collaborative newsletters, brochures, and web pages conveying up-to-date information about (resident nonprofit) programs and services
- Provide staff training and personnel performance training
- Provide a centralized intake process and collaborative counseling, information, referrals, etc.
- Provide a collaborative resource library for the nonprofit organizations
- Offer a safe, healthy, affordable, common facility to the nonprofit organizations

#### **4. a. Achievements of Oaklawn in 2009**

As of December, 2009 Board members reviewed and updated their progress relating to the mission of Oaklawn. Organizations in the building (Head Start, United Way, Rural Dental, Family Resource Center and Reach Day Services) are continuing to report signification collaboration between entities. Through United Way, donations of items are being processed (Walmart Distribution) and being connected back with the Head Start (anchor in the building) and Family Resource families facing issues of poverty. Local churches are providing winter clothing Oaklawn which networks it back to families. Organizations all report an increase in extent of collaboration from household items, transportation, developing projects to address sustainable food sources to better access to dental care. In the past six months, Head Start has begun to utilize a sharing table strengthening the seamless services provided to families, and individuals coming into the building and states often the table is empty. Head Start and Reach Hand in Hand are sharing exercise facilities developed by Oaklawn to improve the physical activities of young children. Oaklawn also developed a website to better communicate and update the community on information about the programs and services available from the nonprofit organizations.

4.b. As of December, 2009 the operational reserves for Oaklawn were reduced slightly as this fall Family Resource Center closed due to elimination of funding and Runva (new startup) terminated their production operation in the manufacturing suite.

4.c As a result of the loss of new manufacturing and non-profit in our organization, the Board of Directors has re-strategized monthly on to better research programs that serve individuals in poverty and

how to reach and nurture start-up companies in the community. Contacts have been made with DVR, and the school system to examine whether a children's program would blend with current organizations or expanding to better serve people with disabilities. We have worked with UW-Stout to better identify new start up businesses that could use the manufacturing incubator.
