The Foundation creates permanent endowment funds and pass-through funds to support educational opportunities in Madison's public schools and provides support to forty-nine schools to raise funds for their endowments and in the annual grant process In 2009, \$44,701 was granted through the individual schools The Foundation also provides support in raising and disbursing funds for twenty-four field of interest and donor designated endowment funds In 2009, \$23,849 in grants was made The Foundation also provides support in raising and disbursing funds for thirty-two pass-through funds The Foundation awards grants for creative and innovative projects in Madison's public schools through a competitive grant process In 2009, nine grants totaling \$46,690 funded projects in eight schools and the school district's teaching and learning department The Foundation also develops supportive relationships between Madison's public schools and the community to enrich the education of children The Foundation hosts an annual principal for a day event to give first-hand experience of what is happening in the schools In 2009, eighty business and community leaders participated in the sixth annual event The Foundation also works with local businesses and organizations to provide human, material, and financial resources to our schools through the adopt-a-school program In 2009, ten new partnerships were formed for a total of twenty-five throughout the school district The Foundation provides opportunities to connect the general public with the schools The annual Circle of Friends luncheon showcases successes in Madison's public schools as well as highlights how the Foundation is able to make an impact through its programs and initiatives The 2009 luncheon had 570 attendees as well as corporate sponsorship In addition, the Foundation's report to the community is passed out as a luncheon program and general update on the past year's activities
