Technical AssistanceWith the help of Worldwide Foundation funding, WOCCU is strengthening the management of credit unions worldwide with technical assistance In Colombia, WOCCU is helping credit unions offer savings accounts and small loans to people living in less developed, rural areas of the country Some credit unions are reaching out to Colombians who have been internally displaced by long-standing political and economic conflict Foundation funds train credit union staff and volunteers on leadership, operational efficiency, marketing and developing new microfinance products In Ethiopia, small farmers often struggle to find the training, market access and financing to move from subsistence farming to commercial production With foundation funds, WOCCU is helping farmers learn new skills to increase productivity, form business partnerships to increase their marketability, and gain access affordable loans that mutually benefit both their community-based credit unions and themselves Worldwide Foundation-funded global initiatives in 2009 included -Creating training programs for management and board members-Connecting credit unions through domestic and international shared branching-Establishing affordable money transfer services for members-Testing new handheld technology to increase outreach and improve efficiency-Creating model credit union regulations for developing systems

EDUCATIONContinued support of WOCCU's Pacific Credit Union Technical Congress demonstrates the Worldwide Foundation's ongoing commitment to training The congress is designed to increase the technical capacity of staff and volunteers serving credit unions in developing countries In 2009, the foundation supported the congress held in Nadi, Fiji and also helped form the Pacific Credit Union Network, an organization designed to provide technical assistance, communications and advocacy support and to develop a Pacific credit union database A new educational WOCCU program funded by the Worldwide Foundation, the Global Women's Leadership Network has a two-fold mission supply women credit union leaders in developed and developing countries with peer-to-peer educational networking opportunities and support WOCCU field projects targeting poverty reduction through women community leaders The network held its inaugural leadership forum in Barcelona, Spain, following WOCCU's World Credit Union Conference in July 2009, with more than 40 women leaders from 18 countries present The network had almost 100 members by year end at three membership levels and supported WOCCU projects benefiting women in Peru, Kenya and Sri Lanka
