Part IX-A, Summary of Direct Charitable Activities

The Clifton Strengths Institute (Institute) awards the Clifton Strengths Prize (Prize) every other year. The purpose of the Prize is to recognize the life's work of Donald O. Clifton, Ph.D. and his enduring influence on the field of psychology. The intent of the Prize is to promote further groundbreaking theory, research and practice in the area of strengths-based psychology. Recipients of the Prize must exemplify one or more of the following:

1. Taking the field of strengths psychology to new areas of inquiry;
2. Establishing a distinguished record of accomplishment in top scientific outlets;
3. Developing a stream of research that inspires new work by other scientists in the field; and/or
4. Leading an organization which supports the core attributes of strengths-based psychology and leadership.

The \$125,000 Prize was presented in 2009. The Institute incurred additional costs in presenting the Prize: \$3,292 travel, \$600 auditorium rent, \$22,096 contract labor and \$2,855 meals/catering of the Prize banquet.

The Institute also supports programs designed to expand the knowledge of academicians/students about strengths-based psychology. Expenses incurred in 2009 included \$295,000 online course development to increase online activity and interaction between teachers and students and \$325 to recognize students.

During 2009, the Institute incurred expenses of \$48,438 for the continued development of a website, communications and computer-based learning platform to support the Institute's strengths courses.
