Basic Needs - Neighborhood House had the largest single site food shelf in Ramsey County, distributing over 620,000 pounds of food to 38,821 individuals, up 12% from 2008 About half of those served were children - 244 refugees were served by the Refugee Resettlement program, up 37% - Asian Meals on Wheels, the only culturally specific Meals on Wheels program in the region, delivered 14,008 meals to 91 elders The program features a traditional Hmong diet Meals are delivered by Hmong speaking drivers
