FORM 990, PAGE 9, LINE 11a MARKET ADJUSTMENT	ADDITIONAL INFORMATION ON INVESTMENT ACTIVITY	On December 13, 2006, the board of directors created an Endowment Fund for SCA 3 research The donor wished to establish the endowment in the amount of \$1,000,000 and transferred stock that at the time of transfer was valued at \$1,042,650 The committee governing the endowment has the authority to distribute any and all earnings or increase in value over the initial \$1,000,000 stated contribution Distributions from the fund will only be used for SCA 3 research and in supporting promising therapies that may lead to an effective treatment or cure for the SCA's, including SCA 3 Only direct costs will be allowed from this fund, no indirect costs will be allowed Once a cure is found, then the board may determine a new use and purpose for the fund, but the original \$1,000,000 shall remain as an endowment An additional condition of the endowment was that the underlying stock could not be sold within one year of the initial transfer During 2007, the stock paid dividends in the amount of \$22,750 00 and other earnings on amounts invested gained \$2,370 11 for total earnings of \$25,120 11 in 2007 \$24,559 14 was then transferred to the general fund for research grant awards However, the market value of the underlying stock dropped by \$369,539 14 to end up on December 31, 2007 at \$654,071 58 In 2008, due to the continued decline in the market value of the donated stock, the stock was sold The donor has reduced the baseline for the permanent endowment funds to \$600,000 with funds over this value to be used for SCA 3 research As of December 31, 2009, the permanently Restricted Net Assets were \$600,000 00 and Temporarily Restricted Net Assets were \$41,584 07
