


MEMBERSHIP AND PROGRAM SCHOLARSHIPS ALLOW PARTICIPANTS TO JOIN THE YMCA ON A SCALE PRORATED TO THEIR ABILITY TO PAY, FREE FROM ANY POSSIBLE SOCIAL STIGMA FROM LOW INCOME. BASED ON THE FEDERAL FREE LUNCH PROGRAM, PARTICIPANTS MAY PAY AS LITTLE AS 25% OF THE NORMAL COSTS FOR MEMBERSHIP AND/OR PROGRAM PARTICIPATION. DURING 2009, THE YMCA PROVIDED 1,668 INDIVIDUALS/FAMILIES WITH SCHOLARSHIP MEMBERSHIPS, SUBSIDIZED THE MEMBERSHIP FEES FOR 436 ST. CLOUD TECHNICAL COLLEGE STUDENTS AND PROVIDED SCHOLARSHIPS FOR SWIM MEMBERSHIPS, HOME SCHOOL PROGRAM PARTICIPANTS, YOUTH PROGRAM PARTICIPANTS AND CHILD CARE IN THE AMOUNT OF \$1,630. WE ALSO PROVIDE FREE SCHOLARSHIPS FOR OIF/OEF FAMILIES WHILE THE SERVICE PERSON IS DEPLOYED, AND SIX MONTHS OF ADDITIONAL FREE SCHOLARSHIP FOR THE VETERAN AND FAMILY UPON THE

THE ST. CLOUD AREA FAMILY YMCA WORKS IN PARTNERSHIP WITH MANY COMMUNITY NON-PROFITS AND SCHOOLS BY PROVIDING DAY PASSES FOR THEIR PARTICIPANTS/MEMBERS TO USE ALL OR A PORTION OF THE YMCA FACILITIES. THEIR PARTICIPATION IN YMCA PROGRAMS AND FACILITIES PROMOTES SOCIAL INTERACTION, OVERALL HEALTH, BUILDS SELF-ESTEEM AND DEVELOPS SOCIAL NETWORKING RELATIONSHIPS. THESE INCLUDE DISTRICT 742 SCHOOLS, BOY AND GIRL SCOUTS, BOYS AND GIRLS CLUBS, YOUTH FOR CHRIST, PLACE OF HOPE, OPPORTUNITY MANOR, JOURNEY HOME, NORTHWAY GROUP HOME, FOCUS 12, NEW BEGINNINGS, ANNA MARIE'S AND BIG BROTHERS/BIG SISTERS TO LIST A FEW.

THE SUPERVISED VISITATION AND EXCHANGES PROGRAM IS IN PLACE TO SERVICE COURT-ORDERED VISITATIONS AND EXCHANGES FOR NON-CUSTODIAL PARENTS. THE YMCA IS A SAFE ENVIRONMENT FOR THESE EXCHANGES/VISITS AND OFFERS MORE THAN A COURTHOUSE OR ATTORNEY'S OFFICE ROOM. HERE, PARENTS AND CHILDREN CAN ACCESS THE FACILITIES TO SPEND QUALITY, ENJOYABLE TIME TOGETHER. WE SERVE COURT-ORDERED CASES FROM COUNTIES THROUGHOUT THE STATE AS WELL AS MANY PRIVATE CASES. ALL CASES ARE SUPERVISED BY SOCIAL WORKERS. MANY OF THESE PARENTS/FAMILIES CANNOT AFFORD THE SERVICES OF SOCIAL WORKERS AND THE COST OF THE SUPERVISION REQUIRED FOR THE VISITS, SO WE PROVIDE ASSISTANCE TO THESE FAMILIES TO SEE THEIR CHILDREN. DURING 2009, 863 VISITS AND 315 EXCHANGES WERE PROVIDED.
