Patient Care The Foundation raises money to support Gillette's patient-care needs The largest fundraising area in 2009 involved charitable support for Gillette's outpatient clinics In 2009, Gillette had 111,367 outpatient visits from people with many chronic and acquired conditions, including cerebral palsy, spinal-cord injuries, spina bifida, brain injuries, complex orthopaedic needs, neurological disorders, craniofacial anomalies and juvenile arthritis

Capital The Foundation also raises money to support Gillette in providing specialty health care for people who have disabilities In 2009, the largest capital fundraising expenditures involved opening an advanced imaging center at Gillette's main campus in St Paul, Minn The center grew more than expected, offering sedation medicine, pain management, positive-distraction technology, low-radiation equipment and a soothing environment to make imaging tests easier for patients who have disabilities See Schedule O In 2009, Gillette began fundraising for renovation and expansions to its hospital facilities in St Paul Gillette redesigned its registration area to promote patient privacy and to be more comfortable for families In October 2009, Gillette broke ground on a new patient-care building in St Paul Gillette also is building a state-of-the-art pediatric intensive care unit, which will open in May 2010
