	KIDSTOP - Our children face an often dangerous and unfriendly world after leaving the relative safety of their home and school At 3 p m , while parents are still working, millions of kids lack meaningful, positive things to do Research shows youth-related crime doubles between 3-8 p m every weekday Given the increased anxiety and pressure brought on by the media, peers and lack of parental guidance, children need adult support and reassurance now more than ever KIDSTOP has provided a safe haven for boys and girls when and where they need us most every day after school at 12 KIDSTOP sites located within the schools Our mission is to enable all young people, especially those who need us most, to reach their full potential as productive, caring, responsible citizens We achieve this by providing youth in grades K-6 with a safe, supportive environment, fun activities, positive relationships with peers and adults, increased opportunities to learn and develop, and recognition of achievements In 2009, we served 4,071 registered members and 3,952 other community youth On average we provided programs and services to more than 900 youth daily, utilizing paid professionals and over 300 adult and junior volunteers

	Units - Unit programs are structured using the Boys & Girls Clubs of America's 140-year-old traditional model - our three Boys & Girls Club units at Southside, Eastside and Roosevelt They are dedicated youth facilities owned and operated by the Boys & Girls Club to serve youth ages 5-18 from school dismissal until 8 p m for kids in grades K - 6th and until 9 p m for teens in grades 7 - 12th Monday through Friday We are on the school bus route at each of our units, and youths check themselves in and out of the program on a daily basis In addition to the programs and services mentioned under KIDSTOP, Boys & Girls Club staff prepare and serve a daily snack and nutritious meal provided in part by Second Harvest Heartland Food Bank and Gold'n Plump Poultry In 2009, we served a total of 27,126 snacks and 40,804 meals at our three units The demographics vary by neighborhood but on average the breakout is as follows Gender is split 50/50, African American 37%, Asian 3%, Hispanic 9%, Multi-Racial 11%, Native American 2%, and Caucasian 38% Between the 3 units, 65% come from single parent families and 86% qualify for free or reduced lunch
