The Lyngblomsten Care Center, a 237-bed skilled nursing facility, provides both short-term rehabilitation and long-term healthcare, including Alzheimers care. In 2009, 542 persons received care. Chaplains, volunteers, and professional staff ensure residents receive quality health care in a dignified manner. Although health issues prevent these seniors from enjoying living in their own homes, Lyngblomsten promotes person-centered care, giving these older adults as many choices and comforts of home as possible. Educational and social events are hosted to enhance the lives of these seniors and their families. A PALS (Passing Along Life Stories) program was recently initiated, where employees from across the organization are paired with a resident for weekly visits enhancing the lives of both the residents and the employees. Newly designed spa rooms greatly enhance the dignity of residents during personal cares. A new program called Purple Wishes granted its first wishes, including a motorcycle ride for one resident and a fishing trip for another. Lyngblomsten Care Center, Inc. is affiliated with Lyngblomsten and the Evangelical Lutheran Church in America
