**Community-based Mediation Services: The goal is to provide individuals in our community with opportunities to move from conflict to resolution - from stuck to unstuck - through accessible mediation services. In 2009, CMS managed 327 community-based mediations, including 164 juvenile mediation services.**

**4b** (Code: ) (Expenses \$ 46,981 including grants of \$ 0 ) (Revenue \$ 48,702 )  
**Juvenile Mediation Services fall into two broad categories: student/student disputes and juvenile-offender/victim disputes. In both areas of service, community mediators trained and coordinated by CMS provide a restorative mediation process that helps participants reflect on what happened, reach agreement on how to repair the harm, and finally, develop a plan to make constructive decisions in the future. In 2009, of the 54 juvenile offenders diverted from Juvenile Court, a total of 87% successfully completed the diversion program. Of the 111 school disputes referred to CMS, over 90 reached agreement and reported the process resulted in improved conflict-resolution and decision-making skills. Community mediation Services, Inc. is a host site for Americorps members and received \$3,658 in inkind support for juvenile services and volunteer-provided community services.**

**Court Mediation Services. CMS seeks to provide court disputants with a fair, accessible, and efficient process that enables them to craft their own unique settlements as part of their day in court. Over 60 community mediators provide mediation services in Conciliation Court (English and spanish), Harassment Court, and Housing Court. In 2009 CMS mediated 919 onsite court disputes with high rates of customer satisfaction. Notably, 95% of participants "would recommend mediation to others".**
