

Activities report for the Duluth Softball Players Association for the softball season April, 2009 through September , 2009 (6 months) as they pertain to our mission of promoting softball within our community.

The DSPA promotes softball activities at the Wheeler/Wade athletic complex. The complex is owned by the City of Duluth, administrated by the Parks and Recreation Department.

The complex is home to: Duluth High Schools girls fastpitch softball teams - Lake Superior Girls Fastpitch summer program - Duluth Area Youth Softball program - West Duluth Little League program - City of Duluth adult recreation softball leagues.

The DSPA has approximately 1045 active members - based on 65 mens' teams, 13 womens' teams, and 16 co-rec. teams playing Monday, Tuesday, Wednesday, and Thursday each week from 6:00 pm to 10:00 pm from May through August.

The complex hosts youth and adult week-end softball tournaments from May through August.

The complex is open to Youth Flag Football and soccer from October to close.

The complex is open to the public for day time activities.
