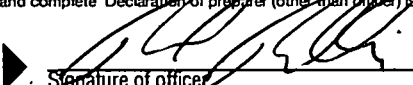

IN 2009, THE NORTH MEMORIAL HOSPICE AND PALLIATIVE CARE PROGRAM SERVED 1,200 PATIENTS. FOUNDATION DOLLARS WERE UTILIZED TO PAY FOR HEATING, UTILITIES, MEDICAL COSTS, EQUIPMENT, AND OTHER EXPENSES FOR PATIENTS. THE FOUNDATION ALSO PROVIDED SUPPORT FOR MASSAGE AND MUSIC THERAPY FOR PATIENTS.

THIS FUND WAS ESTABLISHED BY BREAST CANCER SURVIVOR, MICHELLE MOREY AND HER HUSBAND SCOTT BISSEN IN OCTOBER OF 2005. MICHELLE RECOGNIZED THE NEED TO HELP FAMILIES STRUGGLING FINANCIALLY WHILE GOING THROUGH CANCER TREATMENT. IN FEBRUARY OF 2006, THE FIRST PAY IT FORWARD EVENT WAS HELD AND OVER THE LAST FOUR YEARS - MORE THAN \$500,000 HAS BEEN RAISED TO HELP CANCER PATIENTS AND THEIR FAMILIES. CURRENTLY, THE FUND IS PROVIDING PATIENT ASSISTANCE IN THE AMOUNT OF \$150,000 PER YEAR WITH A MAXIMUM PER PATIENT OF \$1,500. PATIENTS ELIGIBLE FOR ASSISTANCE ARE FROM NORTH MEMORIAL, MERCY, UNITY, AND MONITCELLO HOSPITALS. THE FUND IS ADMINISTERED AT NO FEE THROUGH THE FOUNDATION.

RESIDENTIAL HOSPICE PROGRAM

IN 2009, THE RESIDENCE ADMITTED 112 PATIENTS. TWENTY-THREE OF THESE PATIENTS QUALIFIED FOR THE SLIDING FEE SCALE. THE FOUNDATION OFFSET \$173,000 IN CHARGES THAT PROVIDED A PEACEFUL SETTING FOR THEIR FINAL DAYS. OUR MASSAGE AND MUSIC THERAPISTS VISIT PATIENTS AT THE RESIDENCE IN ADDITION TO THEIR HOMES AND PATIENTS PARTICIPATING ADMITTED TO THE INPATIENT UNIT.
