The Medica Foundation in 2009 made 67 grants totaling \$1,352,969 for projects that address a range of health care issues. Primarily, the projects address needs in the areas of behavioral health, disparities in health care and healthy living. Funding also was provided for worksite wellness and general health improvement programs. Medica Foundation grants support projects that have the potential to make a significant improvement in the overall health of Minnesota’s population. In addition, projects funded by the Medica Foundation help educate Minnesotans about maintaining their health and focus on improved access to much needed care. Examples of selected projects funded in 2009 are provided below: Behavioral Health ProgramsIn 2009, the Medica Foundation provided \$440,000 in funding to projects designed to develop capabilities or change processes related to behavioral health care service delivery, accessibility and sustainability. Sample projects and the amount of funding provided include: - Fraser, Minneapolis, Minn. Grant amount: \$50,000Connect multidisciplinary autism experts with families, health professionals, and education professionals throughout Minnesota through the Telehealth Initiative - Mental Health Consumer-Survivor Network of Minnesota, St. Paul, Minn. Grant amount: \$50,000Train and provide peer advocates in the emergency room of Regions Hospital to support and educate people with mental illness - Minnesota Medical Foundation (Community University Health Care Center), Minneapolis, Minn. Grant amount: \$50,000Integrate outpatient behavioral health with primary care services through an Integrated Care Team to ensure that those with serious mental illness receive appropriate preventive care - Network for Better Futures, Minneapolis, Minn. Grant amount: \$50,000Develop and establish a full-time clinical care coordinator position to help program participants access primary care and behavioral health care services. Ensure compliance with treatment and medication regimens, assure that appointments are kept, and intervene when a relapse or mental health crisis occurs - Parents in Community Action, Inc. (PICA), Minneapolis, Minn. Grant amount: \$50,000Promote the mental health of young children by augmenting classroom curricula. Provide accessible therapeutic treatment to low-income children, and assist classroom teachers in working with children who have behavioral challenges - Regents of the University of Minnesota, Minneapolis, Minn.
