Pilot Study Research Grants: Research grants provide funds to young investigators to conduct initial research and trials related to disorders of skeletal muscle, neuromuscular function and the central nervous system. In 2009, continued funding was disbursed on two existing grants while two other grants were in the final stage of research. The goal of Pilot Study Research Grants is to fund research that could lead to large-scale outcome studies or demonstrate the cost effectiveness and/or cost benefit of electrodiagnostic studies (using evidence based medicine standards).

4b (Code:) (Expenses \$ 12651 including grants of \$ 11920) (Revenue \$)
Awards: The AANEM Foundation for Research & Education supports its educational and research goals by funding several awards each year. Each award gives physicians the opportunity to be recognized among their peers for their work in research. The awards given include the Golseth Young Investigator Award which is presented to encourage young physicians to conduct research in electrodiagnostic medicine (1 award, \$2358); Best Abstract Award which is presented to the best abstract based on scientific merit, well written, excellent discussion, importance to the field, and/or fascinating case (1 award, \$1608); President's Research Initiative Award which is based on abstracts pertaining to an area of interest of the President (9 awards, \$4500); Junior Member Recognition Award given to AANEM Junior Members who are the first author and presenting author of an approved abstract. This award is given to encourage young physicians to conduct research in the fields of neuromuscular and electrodiagnostic medicine (7 awards, \$1400); the Olney Lectureship Award is given to the person chosen to present the titled Plenary session at the AANEM Annual Meeting (1 award, \$2054)

Fellowships: The AANEM Foundation for Research & Education provides fellowship stipends for physicians in economically disadvantaged countries to attend the AANEM Annual Meeting. In 2009, three \$1000 stipends were given to physicians from the following countries: China, Republic of Georgia, and Brazil. In addition to the stipend, the physicians registration fees for attending the AANEM Annual Meeting were waived.
