River Valley Riders provides horse related activities including therapeutic riding and driving to children and adults by addressing needs in the areas of physical, sensory, neurological, and/or mental health.

Line 28 - Therapeutic Horseback Riding - River Valley Riders served 58 people with special needs who participated in weekly lessons of therapeutic horseback riding and carriage driving.

Line 29 - School Programs - River Valley Riders served 87 children with disabilities through school programs and "Special Kids Day".

Line 30 - Newsletters/Web Site - River Valley Riders produced 2 newsletters and maintained the River Valley Riders website to provide information about therapeutic riding and driving to our participants, volunteers, supporters and the community.
