HEALTH EQUITYISATIAH understands that health is connected to economic and racial justice. Thus our work on Health Equity is closely tied to our work in other policy areas. In the spring of 2009, we organized 26 gatherngs and actions around the theme of 'Healthy Communities.' We involved 850 community members, 46 legislators and 32 other public officials to discuss healthy communities, suburban housing policies and transit funding. We also wrote and supported a Healthy Communities Act for the 2009 legislature, although it was not passed. We successfully supported the "Cover All Kids" bill, allowing Minnesota families to purchase subsidized health insurance for their children. In addition to the campaign for health care reform at the federal level, we have: *Developed a large rapid response team of 550 people that has kept the pressure on for real reform. *Organized over 60 health care Sundays. *Partnered with our allies on multiple actions. *Met with our Members of Congress multiple times in district and in D.C.

TRANSPORTATION AND JOBSFrom the federal stimulus funds, Minnesota received more than \$502 million in payments, 70% of it for transportation funding. We have responded by stepping up our attention to transportation and transit resources. Where does the money go? What sort of projects does it fund? Who benefits? How is the investment tracked? In particular, we have focused on insuring that federal (and state) transportation funding in Minnesota will benefit women, minorities and low-income communities, and that they will be guaranteed training and recruitment as part of any transit funds. In monthly meetings beginning December 2008, we worked with contractors, building trades unions, transportation officials and others to negotiate goals, outcomes and accountability for the federal resources. With partners such as Summit Academy OIC, and a new coalition HIRE MN, we worked to push the Minnesota Department of Transportation (MnDOT) to meet workforce goals. We brought 30 faith leaders and 100 other community members to scrutinize MnDOT's results at a House Transit Oversight Committee. We are working closely with Congressmember James Oberstar, Chair of the House Transportation Committee, and the leader who will be drafting the upcoming federal Transportation Reauthorization bill, to express our values and policy vision for transportation equity. ISATIAH leaders have met with Oberstar and his staff over half a dozen times in the past year. His staff attended a 400-person gathering of faith leaders and elected officials in August in which community members gave testimony on transportation equity and job creation. Attendees wrote over 250 letters to Congress and videotaped testimony. These proceedings will be included in the Congressional Record. We have also been successful in pushing for improved transit within the metropolitan region. The Central Corridor Light Rail project is a planned transit line, which seemed, upon initial planning, to omit three critical stops in underserved communities. Our campaign galvanized the community to demand equal access to this transit line. We organized a public meeting with 3,300 community members and 200 policy-makers to insist on inclusion of these three stops in the development of the Central Corridor. Another gathering of 800 people in St. Paul brought the same message to 50 more elected officials, including the Mayor of St. Paul. We then brought key legislators into conversation with some of the community members they represent. We organized a series of meetings, each of which included 25 to 40 members of a local church paired with a County Commissioner or State Senator. On August 26th, we achieved victory: the City of St. Paul formally committed funds to build one of the three missing stops, and promised to build the remaining two.

RACIAL JUSTICEThe area of racial justice has been a significant strategic focus for our work, and our organization has wholeheartedly committed itself to being a truly and deeply multi-racial organization. In the last year: *We have engaged and worked closely with ten new African-America congregations, holding one-on-one conversations with their pastors and involving their membership in our education and outreach work. *We sent fifteen African-America leaders to a national week-long training program. *We involved 150 people in two Strategic Leadership gatherings with Professor John Powell - Executive Director of the Kirwan Institute for the Study of Race and Ethnicity at Ohio State - to delve into issues of race, power, faith and regional politics. *We intentionally built multi-racial action teams for our work on education, transportation equity and jobs. *We created a temporary committee to steer the organization towards truly multi-racial leadership and staffing. *We added two new staff of color, so that today four out of our nine organizers are people of color: one African-American, one Latino, one Hmong-American and one Japanese-American. *We brought four people of color onto the clergy planning table and the planning teams of four of our regional caucuses. Our Steering Team for long-term planning now has six people of color out of a total of thirteen members.
