II NSPTCC's Provision of Care and Other Services to the Community NSPTCC is organized and operated exclusively to perform the functions of a skilled nursing facility to provide transitional health care to patients, including critical care skilled nursing and rehabilitation therapy. Transitional care services are typically short-term skilled nursing services provided on an inpatient basis, often following discharge from a hospital and prior to the patient's return home. The average length of stay for patients at NSPTCC's facility is less than 12 days. Transitional care services fill a critically important gap in the health care continuum and reduce the cost associated with extended stays in more expensive inpatient facilities. NSPTCC has provided sub-acute transitional care outside of a traditional hospital setting to patients for over ten years. Treatment is provided either immediately after, or, instead of, an acute hospital stay. Discharge planning is considered a key component to the care planning process. NSPTCC also aims to provide medical capabilities that complement patients' needs, including, for example, obese patients who require special assistance and patients who rely on expensive therapeutic medications. NSPTCC has also developed a hospice program and has a hospice suite to serve terminal patients in the community. NSPTCC is licensed under Minnesota Statutes as a nursing home with a capacity of 32 beds. NSPTCC participates in the traditional Medicare program and the Medicare Part A managed care program and is certified as a Medicare skilled nursing facility. NSPTCC's fees are established to cover its costs in providing care and to ensure its continued ability to pursue its mission. Nurses and therapists are located onsite to provide physical and occupational therapy seven days a week. Speech therapy is provided five days a week. NSPTCC accepts admissions 24 hours a day, seven days a week. NSPTCC receives a significant number of patients from Regions Hospital. Regions Hospital is a full-service, tax-exempt hospital providing medical and surgical care, with special programs in heart, women's care, cancer, senior services, burn, emergency care and Level I adult and pediatric trauma. For Regions Hospital's 2009 community benefit activity, please see the Regions Hospital Form 990. Discharging inpatients to a transitional care center, such as NSPTCC, when it is medically appropriate reduces the overall cost of care which is borne by government, commercial insurers and patients. Regions Hospital also discharges uninsured patients to NSPTCC who no longer require hospital care and are unable to pay for NSPTCC for their care. Regions Hospital financially supports NSPTCC's provision of care to these patients. In 2009, Regions provided \$52,014 to NSPTCC to care for these charity care patients. But, even with this payment, Regions Hospital significantly reduces the cost of caring for these patients due to the lower cost of care in the non-hospital setting. Further, discharge of uninsured patients who no longer require hospital care enables Regions Hospital to release beds for use by patients who require hospital care. In addition to serving patients in the community, in 2009 NSPTCC continued to provide community service outreach such as participating in adopt a highway, hosting a school supply drive, and offering free monthly blood pressure checks. NSPTCC also collected enough donations to sponsor eleven complete Thanksgiving meals for local families. Additionally, NSPTCC staff serve on community boards and committees for various professional organizations including Association of Social Work Boards, Rasmussen College Nursing Program, and Aging Services of Minnesota.
