We started the weekend with a dinner and gathering at the Field House. On Saturday, we began the day with our seminar by sharing stories. It was an emotional and rewarding time for all. The Phillies donated tickets for our families to take in a game later that day. Sunday, we said our goodbyes, until we meet again next year.
