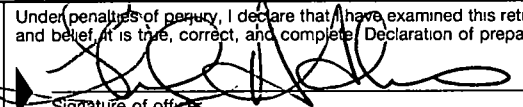

This was achieved through a) member mailings; b) distribution of invited reviews, a professional peer reviewed journal (Muscle & Nerve), email announcements, and a quarterly newsletter; c) creation of educational podcasts, practice parameters, consensus guidelines, and position statements; and d) providing information to the members through the association website.

Annual Meeting - The purpose of the Annual Meeting is to provide physicians with a large forum to exchange ideas and provide continuing education for updating and acquiring greater knowledge about the diagnosis and treatment of neuromuscular diseases. The meeting also offers an opportunity to learn about new diagnostic techniques to improve patient care. These were achieved through a variety of hands-on workshops, courses, expert roundtables, discussion groups, demonstration sessions, symposia, plenary talks, special interest group sessions, abstract reviews and presentations, industry forums, and an exhibit hall containing the latest equipment, supplies, books, periodicals, and pharmaceutical treatments to aid and improve patient care.

Education and Publication - The purpose of Education and Publications services is to distribute educational materials to physicians interested in the fields of neuromuscular and electrodiagnostic medicine to increase physician competence. This purpose was achieved by providing printed educational materials, videos, DVDs, CD-ROMs, teleconferences, and brochures that educate physicians, physician-in-training, patients, and the general public. The material provides information about the field, explains the procedures used to diagnose neuromuscular diseases, and discusses treatment options. The goal is to improve patient care.
