Residential Treatment program provides a safe and secure living environment for at risk youth. There is a school on campus which is staffed by special education teachers in cooperation with the Johnston Public Schools, 50-bed residential living cottages for Iowa teenage boys, recreational space, and an administration building. The Pre-Independent Living program began in 2004 and is designed for 10 teenage boys who are living at the Ross Campus Treatment Center. All of these boys will be part of the Iowa Juvenile Justice System until they reach their eighteenth birthday. All these youth are in need of the more structured living and learning atmosphere that is provided on Ross Campus. The program served 127 children in 2009.

**4b** (Code: ) (Expenses \$ 1,021,483 including grants of \$ 0 ) (Revenue \$ 0 )

Remedial services consist of skill building services designed to improve the Client's functioning by using cognitive, behavioral or social interventions. This may include communication skills, conflict resolution skills, problem solving skills, social skills, and interpersonal relationship skills. The focus of the service is to reduce the symptoms/behaviors that negatively affect a client's ability to function at their best possible level with minimal interference. 164 clients/families were served in 2009.

**4c** (Code: ) (Expenses \$ 217,803 including grants of \$ 0 ) (Revenue \$ 0 )

Apartment based Independent Living program began in 1991 and works with boys and girls ages 16-18 years old. It is designed to provide supervision and counseling to youth who are about to reach their 18th birthday and "age out" of the Juvenile System. These clients have little or no family support and are in need of significant adult mentoring. Some are also young teenage moms who are attempting to care for one or more children. Clients receive training in daily living, money management, coordination of basic educational needs, vocational and job preparation, and teenage parenting. In 2009, 54 individuals were served.
