In cooperation with the Iowa Natural Heritage Foundation (INHF), an 840 tract located within the authorized boundary of the Refuge was purchased at public action for \$2.7 million in 2007. The INHF will hold title until the tract is transferred to the USFWS. The Friends agreed with the INHF to contribute \$1.5 million for the purchase. \$1,363,000 was paid to INHF in 2008 and the remainder, \$137,000 was paid in 2009. It is the intent of both the Friends and the INHF to transfer the tract to the USFWS at or near the appraised value. Any funds remaining from the purchase by the USFWS will be used, first, to repay the INHF's net outlay. The remainder will be returned to the Friends and used for other projects at the Refuge. The Friends revenue for this project is available from a large bequest being paid to the Friends in periodic payments from 2007 to 2012.
