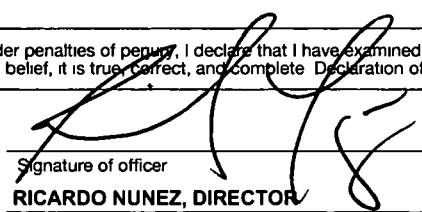

Statement 1

The exempt purpose of the HD Supply Charitable Fund, Inc. (or "HDSCF") is to provide emergency assistance to HD Supply associates facing financial hardship due to unavoidable circumstances. It's a vehicle to help facilitate employees helping other employees in need. The majority of HDSCF's funding currently comes from employee cash and payroll related donations. HD Supply refers to HD Supply, Inc. and its affiliates.

Direct charitable grants are made for temporary housing, utilities, food, clothing and other necessities due to fire, death, illness, injury or natural disaster. These grants are available to all active HD Supply employees and their immediate family members or members for which they are financially responsible, but limited to individuals that are unable to pay bills for essential life expenses, essential utilities, rent or mortgage hardship, or funeral costs due to the qualifying circumstances.

HDSCF requires the employee applying for assistance to fill out an application and attach any other supporting information and documentation relevant to the situation (past due utility bills, etc). HDSCF also maintains a case history on every applicant.

HDSCF's operations are conducted by an Operating Committee that is separate from the boards of HD Supply or HD Supply Charitable Fund. This Committee is composed of seven employees of HD Supply who are neither directors nor officers of HD Supply or HDSCF. The rationale behind the composition of the Committee is for applications to be reviewed by a broad, cross section of individuals who understand that they are acting in a personal capacity as agents of HDSCF rather than as representatives of HD Supply, Inc.

The Committee meets every other week by phone to discuss the applications received. The decision on when to provide support comes from an objective based analysis of each application and ultimately a vote by the committee. Awards are determined based on an associate's eligibility to apply under a qualifying circumstance as defined in the application, as well as the associate's supporting summary description and evidentiary documentation supporting the claim. An associate or qualified family member may currently receive up to \$1,000 per year from the HDSCF and may apply as many times as needed, provided the total award amount for the year does not exceed \$1,000. Officers and directors of HD Supply and HDSCF are not eligible to receive support.

As mentioned, the grant making process is currently funded entirely through employee donations. Employees can donate through the HDSCF website. Contributions are also expected to be received from the HD Supply Foundation in the future.
