Class 3 members of the Board of Governors are directors, officers or employees of the United States Anti-Doping Agency (USADA) and potentially, other non-profit or public sector representatives who, in the judgement of the Board of Governors, by majority vote, are committed to PCC's purpose and mission.

Any questions or concerns will be directed to the attention of the President.
