

BANK-RELATED BUSINESSES PROVIDING PRODUCTS AND SERVICES ARE ENCOURAGED TO PARTICIPATE IN THE EXHIBIT AND TRADE SHOW AT THE ANNUAL CONVENTION. SPECIAL INFORMATIONAL AND EDUCATIONAL PROGRAMS ARE HELD IN CONJUNCTION WITH THIS ANNUAL MEETING. IN 2009 THERE WERE APPROXIMATELY 82 EXHIBITORS, 135 BANKERS REGISTERED, AND APPROXIMATELY 125 OTHER REGISTRATIONS.

WORKSHOP TOPICS RELATED TO ISSUES OF IMPORTANCE TO THE BANKING INDUSTRY FOR BANK DIRECTORS AND MANAGEMENT ARE PRESENTED IN AN INFORMAL AND RELAXED ATMOSPHERE. IN 2009, THERE WERE 100 REGISTRATIONS.

THE ASSOCIATION'S EDUCATION PROGRAM PROVIDES TELEPHONE, ON DEMAND WEB LINKS, AND AUDIO-VISUAL CD-ROM SEMINARS. THESE SEMINARS ARE AFFORDABLE, EFFICIENT, AND EFFECTIVE TRAINING OPPORTUNITIES BROUGHT IN-HOUSE TO COMMUNITY BANKS. ONE OR TWO LIVE SEMINARS PRESENTED VIA TELEPHONE, INTERNET OR CD-ROM ARE OFFERED EACH WEEK. IN 2009, 102 TELEPHONE/WEBCASTS WERE OFFERED, 82 DIFFERENT MEMBER BANKS PARTICIPATED, AND 203 REGISTRATIONS WERE RECEIVED. THE ASSOCIATION ALSO HELD A 2009 SPRING SEMINAR FOR FRONT-LINE BANK EMPLOYEES AT 7 DIFFERENT LOCATIONS IN MISSOURI TO ALLOW EASIER COMMUTING. THE TOPIC OF THIS TRAINING SEMINAR WAS "CUSTOMER SERVICE" AND 18 MEMBER BANKS SENT A TOTAL OF 200 EMPLOYEES.
