projects to fix, upgrade, and improve the camp. We brought over 175 students from Kirksville, MO to Alabama all for
\$150 per person (everything included). While at camp, we work, have time to play sports and games, time for bible
study and worship, and 1 free day for fun. Some years we have a surplus from this project, other years we run a
deficit due to small factors like fuel price, vehicle breakdowns, or food costs.

CCF Freshman week: When the freshman arrive to start the new academic year, CCF has a week of events to
welcome old and new students. We have a meal that is free to students, games, giveaways, activities, worship, and
