The Organization acquired donated excess and obsolete business equipment and inventory (approximately 1,350 tons) from area businesses, thus diverting them from the waste stream. Member not-for-profit organizations selected needed, usable items from the Organization's inventory, paying only a small handling fee. Items that the not-for-profits do not want or cannot use are offered to the general public or other surplus markets in an effort to keep them out of the landfill and to generate revenue to keep the fees to the not-for-profit members low. Approximately 1,200 local charities benefitted.
