Grevy's Zebra Trust works in the Horn of Africa to conserve Grevy's zebra across its range in collaboration with local communities.

Northern Rangelands Trust's mission is to develop resilient community conservancies which transform people's lives, secure peace, and conserve natural resources.

The Humboldt Penguin Conservation Consortium supports the operation of a field station in Punta San Juan, Peru, including two biologists and a guard to assist with maintaining the wall protecting the reserve.

The mission of the Sahara Conservation Fund is to conserve the wildlife, habitats and other natural resources of the Sahara and its bordering Sahelian grasslands.
