The Camp Ministries program held camping activities at eight separate camping facilities. In 2009, 348 families were served at the K-Kauai Family Kamp. The other seven kid-camps served ALMOST 13,000 children and teens. Campers are encouraged to grow in their relationship with the Lord, their families, and their friends. The K-Kauai facility also provides classroom and lodging accommodations to 70 graduate students studying to become youth ministers through the Kanakuk Institute. This program had a significant increase in participants over 2008 due to donation of camp facilities received during 2008.

4b (Code) (Expenses \$ 896,660 including grants of \$ 47,808) (Revenue \$ 44,158)

The Campus Youth Ministries program held 20 AFTERdark events and five Pure Excitement events in 2009. Over 30,000 college and high school students attended the events, with approximately 12,000 students making commitments to begin or renew a relationship with Christ. Each attendee receives biblical literature with principles for spiritual growth.

4c (Code) (Expenses \$ 530,808 including grants of \$ 379,796) (Revenue \$ 0)

The Kanakuk International Program includes Kanakuk Haiti, a program to support the educational, nutritional, and spiritual needs of over 5,000 students at 17 schools in Haiti. In addition to the support in Haiti, Kanakuk International sent 39 students on mission trips to Rwanda in 2009.
