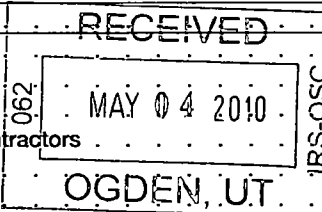

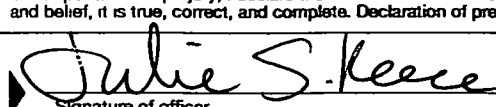

The income reported on Part 1, Line 2 is not unrelated business income. The income is from fees for language education programs and books for the language programs which is substantially related to the One World Language School's educational purpose that is the basis for our exemption.
