In response to Part VI, Part A, Questions 6, 7a, 7b: The active membership is composed of all of the voting members and officers of the executive board. The members of the executive group are elected by a majority of the active membership as determined in the Constitution and Bylaws of our organization. Terms are served on a calendar year, with elections held in the Fall & newly elected officer assuming office the following January. All decisions on business must be approved by a simple majority, unless otherwise specified in the Constitution and/or Bylaws. Executive group members are sometimes allowed to make decisions within the jurisdiction of their office. For example, the budget is determined by a finance committee composed of elected members and headed by the Treasurer.

VI.B. Question 11: The Form 990 is completed by the Treasurer who is serving his term, along with the assistance of the previous treasurer and Alumnus Treasurer (as elected by an Alumni Board). The Form is reviewed by the finance committee and Treasurer.

VI.B. Question 15b: The amount that the officers (namely the treasurer) will be compensated is determined by a motion that must be approved by the active membership to amend our constitution. This motion must be approved by 2/3 majority. The contract which determines the salary of our chef is determined by the finance committee headed by the Treasurer, all of which are elected members by the active membership.
