The Medcenter One Rehabilitation DepartmentFor the past 13 years, the Medcenter One Foundation has partnered with the Medcenter One Rehabilitation Department to plan and implement the Great American (Stationary) Bike Race benefiting children afflicted with cerebral palsy or related disorders This bike race, held each April, has grown to become the largest fundraiser of its kind in the United States, generating over \$200,000 in gross income for the past three years alone and over \$1 million over the last 13 years All monies raised are sub-granted to families in need to provide therapies, adaptive equipment, home renovations and van conversions not normally covered through insurance programs or third party payees During 2009, \$238,000 was disbursed to families needing assistance to provide for their special children

The Medcenter One Children's Hospital Amber's DreamAmber DesRoches was just 15 years old when leukemia took her life in the days preceding Christmas, 2007 In time, and despite unbearable grief and sorrow, Amber's family couldn't help but remember how the teenager often talked about transforming the Children's Hospital here at Medcenter One When she wasn't telling someone what she envisioned for the children who would be hospitalized after her, she pencilled her thoughts in her journal In the aftermath of her death, Amber's Dream was given life Amber envisioned a Children's Hospital where everything was possible and nothing was impossible Amber wanted sick and injured children to have a place of their own, a place that looked and felt different from the rest of the hospital Amber yearned for an environment that was warm, inviting and nurturing, a place where children's fears could be eliminated and their pain diminished Amber was particularly enthralled with the adventures the children depicted within Peter Pan took each and every night The magical journeys the children took---journeys that led them to pirates, mermaids, Indians, fairies and tree people---captivated her attention---and she felt, would capture the imagination of children who would become patients long after she left This was the essence of Amber's Dream While Amber was envisioning a magical place, the leadership of Medcenter One, Inc was planning a long overdue expansion and renovation of the Children's Hospital Everyone agreed---this expansion and renovation project was deemed critically important Amber's Dream of transformation was skillfully blended with the hospital's plans for expansion and renovation The project would be known as "Amber's Dream" and would become a reality upon the successful completion of a \$695,000 major gifts campaign At the conclusion of 2009, a total of \$531,573 had been paid, pledged and promised to the Foundation for Amber's Dream
