Public Policy & Legislative Advocacy ACE's public policy strategy is to provide grassroots-driven leadership and advocacy for legislation at the state and federal level that supports the production and use of ethanol Specific focus is on policies that create demand for ethanol Major Achievements within Program A) ACE organized a successful grassroots member "fly-in" to Washington, DC During this event, which generated significant and positive media attention for ethanol, ACE members met with more than 70 Members of Congress and Lisa Jackson, Administrator of the Environmental Protection Agency (EPA) ACE members focused on several key issues, including the need to overcome the E10 blend wall, promoting midlevel blends of ethanol and blender pumps and Flexible Fuel Vehicles, fighting against unscientific International Land Use Change (ILUC) penalties, and promoting the economic, energy security and environmental benefits of ethanol B) ACE submitted a waiver requesting that EPA allow E15 use in vehicles in partnership with Growth Energy, the Renewable Fuels Association, National Corn Growers Association and others ACE-sponsored research on ethanol use in autos was used as evidence to justify the waiver request After the waiver was submitted ACE launched a national grassroots campaign to support the E15 waiver, including organizing E15 rallies, creating an E15 action center on www.ethanol.org, and initiating an online petition drive, resulting in 7000 people from all 50 states signing a petition to EPA in support of the E15 waiver C) ACE testified before Congressional committees on various topics, including International Land Use Change (ILUC) penalties and succeeded in helping enact a provision in the U S House of Representatives to ensure that EPA takes more time to study ILUC before implementing penalties against corn ethanol

Market Development, Research & Promotion ACE takes aggressive steps to develop new markets for ethanol by providing technical expertise and practical information to fuel marketers and retailers to increase the use of ethanol-blended fuel, such as E10, E15, E20, E30 and E85 ACE targets retailers in emerging markets throughout the U S to ensure they have useful information on the benefits of ethanol Particular focus is on new mid-range ethanol blends, such as E20 and E30, and the installation of blender pumps ACE cosponsors research on the use of mid-range blends of ethanol Major Achievements within Program A) ACE developed a national and targeted campaign to install 5000 blender pumps across the U S over the next three years and asked the Renewable Fuels Association to partner with us on the effort The resulting "Blend Your Own Ethanol" BYO Ethanol campaign brings ACE, RFA, the National Corn Growers Association and several state corn grower associations together to expand ethanol's availability nationwide B) Helped secure the installation of dozens of blender pumps around the nation and raised the awareness of the benefits of blender pumps and midlevel blends
