DURING THE YEAR 2009, FUNDACION TELETON MEXAMERICA ("FUNDACION") PROVIDED SUPPORT TO TELETON CHILDREN REHABILITATION CENTERS THE GRANTEE IS AN ORGANIZATION THAT DESIGNS, CONSTRUCTS, INSTALLS AND OPERATES CENTERS FOR REHABILITATION, AND DIAGNOSIS OF UNDERPRIVILEGED CHILDREN WITH PHYSICAL DISABILITIES WITHIN THE MEXICAN TERRITORY IN THE PRESENT TIME IT OPERATES CENTERS LOCATED IN THE MEXICAN STATES OF MEXICO, JALISCO, OAXACA, AGUASCALIENTES, COAHUILA, GUANAJUATO, HIDALGO, CHIAPAS, CHIHUAHUA, QUINTANA ROO, TAMAULIPAS, YUCATAN, VERACRUZ AND DURANGO IN NOVEMBER 2010 IT WILL OPEN TWO MORE CENTERS IN BAJA CALIFORNIA AND SONORA ALL 15 TELETON REHABILITATION CENTERS HAVE THE SAME COMPREHENSIVE MEDICAL MODEL - EMPHASIZE PREVENTIVE CARE - FOCUS ON INTERDISCIPLINARY REHABILITATIVE MEDICAL CARE BY COORDINATING SPECIALIZED CLINICAL ATTENTION WITHIN THE OVERALL REHABILITATION PROCESS - PROVIDE SPECIALIZED CARE IN PHYSICAL THERAPY, OCCUPATIONAL THERAPY, SPEECH THERAPY, MULTIPLE EARLY STIMULATION, NEURO-THERAPY, PSYCHOLOGICAL NEEDS, PARENTING, NURSING CARE, AND SOCIALIZATION SKILLS - OFFER YOUNGSTERS WITH DISABILITIES A COMPREHENSIVE REHABILITATION MODEL AIMED AT INTEGRATING THEM INTO THEIR FAMILIES, SCHOOLS AND SOCIETY AT LARGE - RELY ON A FAMILY CENTERED MODEL THE FIRST GRANT PROVIDED THIS YEAR WAS USED BY THE GRANTEE TO PURCHASE LOKOMATS THE LOKOMAT IS A COMPUTERIZED ROBOTIC SYSTEM USED TO REHABILITATE AND GIVE MOBILITY TO THE LOWER LIMBS AND TRUNK IN PATIENTS WITH NEUROLOGICAL DISEASES AND INJURIES THIS ROBOT GREATLY ACCELERATES THE PROCESS OF REHABILITATION AND ALLOWS THERAPIES TO BE MADE WITH ALL CARE IN THE MOVEMENT BECAUSE IT COMPENSATES FOR THE WEIGHT OF THE PATIENT, MAKING THE MOTION SMOOTH AND CAREFUL THE RESULTS FOR THESE THERAPIES ARE EQUIVALENT TO HAVING BETWEEN 4 AND 5 THERAPISTS WORKING TOGETHER AT THE SAME TIME, COORDINATED PERFECTLY WITH EACH PATIENT FOR THIS REASON, FUNDACION DECIDED TO GIVE SUPPORT FOR EACH ONE OF THE 15 TELETON CHILDREN'S REHABILITATION CENTERS, BECOMING THE MOST EQUIPPED REHABILITATION CENTER IN THE WORLD THE SECOND GRANT WAS USED BY THE GRANTEE TO PURCHASE EQUIPMENTS NECESSARY FOR THE CENTRAL REAHABILITATION AREAS IN THE TWO NEW CENTERS LOCATED IN DURANGO AND VERACRUZ PHYSICAL THERAPY, HYDROTHERAPY, FINE MOTOR THERAPHY (OCCUPATIONAL THERAPY) AND SPEECH THERAPY IN ADDITION, THE GRANTEE WAS ABLE TO MAKE THE PURCHASE OF TWO ANESTHESIC UNITS THESE ARE USED WITH SOME CHILDREN THAT CAN NOT CONTROL THEIR MOVEMENTS IN ORDER TO BE ABLE TO RECEIVE SPECIFIC TREATMENTS (DENTAL FOR EXAMPLE) AND FOR DIAGNOSIS PROCEDURES
