


EARLY CHILDHOOD CONNECTIONS PROVIDES TRAINING AND SUPPORT SERVICES TO ADULTS WHO CARE FOR YOUNG CHILDREN IN HOMES, CHILD CARE CENTERS, PRESCHOOLS, AND HEAD START PROGRAMS. IN 2009 EARLY CHILDHOOD CONNECTIONS IMPACTED 1,953 INDIVIDUAL CHILD CARE PROVIDERS THROUGH TRAINING OR TECHNICAL ASSISTANCE. EARLY CHILDHOOD CONNECTIONS HELD 505 CLASSES FROM JANUARY 1 THROUGH DECEMBER 31, 2009. MANY PARTICIPANTS ATTENDED MORE THAN ONE CLASS; THEREFORE, THE TOTAL CLASS PARTICIPATION WAS 6,767 WHICH REFLECTS AN AVERAGE ATTENDANCE OF 13 STUDENTS PER CLASS.
