	Identify resource gaps in support of economic development and proactively educate, collaborate and innovate toward solutions. Share a diversified toolbox of resources to support economic development that enhances strengths of partners and allies. Challenge the economic development establishment to collaborate strategically for the future of South Dakota. SD Rural Enterprise's Capital Investment Fund (CIF). A \$10 million loan fund making flexible capital available to South Dakota CDFIs. The CIF was 99.84% deployed at 2009 FYE based solely upon CIF capital and lending. \$7.985 million of the CIF capital is from Equity Equivalent Investments (EQ2s), \$1,055,000 Corporate investors, \$1,852,000 in Capital Grant, and \$554,576 Board allocations from the Dakotas America New Market Tax Credit (NMTCT) dividends. The CIF is the economic engine of SD Rural Enterprise, generating a 2% margin. More importantly it is a significant source of flexible capital for CDFIs in the state as it 1) provides reasonably priced capital 2) on a ten year interest only term that 3) does not have restrictions on the kinds of deals it can finance, and 4) can be used as Federal match. An additional financial product is the Rural Business Enterprise Grant (RBEG). Loan participation program that selectively participates in loans originated by our Capital Investment Fund (CIF) borrowers and SD Community Capital Fund (SDCCF) participants. Four loans totaling \$123,473 were outstanding at FYE 2009. Over the history of the program fourteen businesses have received a total of \$533,915 in financing. Due to the downturn in the economy, the SDCCF program became limited due to loan purchaser being limited to projects based in low income census tracts qualifying for New Markets Tax Credits. Community Services Dakota Rising Rural Entrepreneur Fellowship Program designed to spur a renaissance of South Dakota's rural economy. This Pilot program is in year 2 with plans to roll out statewide in 2011. Dakota Rising is designed to spur a renaissance of South Dakota's rural economy through strategic partnerships with local communities to invigorate rural entrepreneurs and their enterprises. By deeply investing financial and human resources we grow individual entrepreneur skills and their businesses. LeadershipPlenty South DakotaThis program is a guide for successfully empowering citizens to make decisions that will determine the future vitality and viability of their community. Creating a Value Added CommunityCreating a Value-Added Community (CVAC) is a product of the Northwest Area Foundation (NWAf). It was designed to help communities develop strategies for poverty reduction, while planning for economic development. GROWGrowing Resources and Opportunity Within (GROW) helps community development organizations access feasibility, plan, recruit and train staff. Opportunity Roundtable TeleconferenceStatewide Opportunity Roundtables, conversational teleconference and information exchanges with community leaders joining in to talk about what works and what doesn't in growing opportunity in South Dakota.
