Individual compensation levels are determined by the General Manager/CEO in compliance with the cooperative's wage and salary administration policy which utilizes a state, regional and national compensation survey.

Form 990, Part VI, Section C, line 19 - The cooperative's governing documents, conflict of interest policy and financial statements are available to the cooperative's members but not the general public. Bylaws and financial statements are routinely provided to the members. The conflict of interest policy would be provided to a member upon request.
