The Foundation funds various needs of the Renaissance Health Clinic. The clinic is a joint community project involving Methodist Hospital and the Salvation Army that helps meet the health care needs of Omaha's low-income population within an atmosphere of caring and respect. Advanced practice registered nurses offer both walk-in and scheduled appointments. A sliding fee scale is used based on the patient's ability to pay. Free or low cost services include physical exams, treatment of minor and chronic health problems and illnesses, physician referrals, health education, family planning services, adolescent routine care, school physicals, HIV testing and risk counseling, STD testing and treatment and treatment for victims of sexual assault and domestic abuse. In addition, the Foundation helps with the Operating costs for the Sexual Assault Nurse Examiner and Sexual Assault Response Team (SANE/SART) Survivor program, a program unique to Methodist Hospital, for the specialized care of sexual assault victims. As of 2006, the program had addressed more than 300 cases of victims of sexual assault. The program is open 24 hours a day, seven days a week. Survivors of all ages have access to care, regardless of their ability to pay. A separate waiting area and treatment unit is available, along with medicines, equipment, a shower and appropriate clothing for survivors to wear home. When a victim comes to the unit, three on-call professionals are alerted: a SANE nurse, an advocate from the YWCA, and a law enforcement officer. Together, this team provides the critical, comprehensive and compassionate attention these victims need. The Foundation made significant capital contributions to the Nebraska Methodist Hospital for use in construction projects. Educational opportunities were made available to healthcare personnel with excellent academic standing and in financial need to begin their education or increase their knowledge. The foundation also provides funding for new technology in education as well as assistance to students of the Nebraska Methodist College of Nursing in urgent and genuine need among other educational programs. The foundation has a nursing loan forgiveness program to help attract and retain good nursing staff. The Foundation has been instrumental in soliciting and providing the funding for a new women's hospital and capital improvements at the existing hospital of \$4,598,925 during 2009.
