	In 2009 Physicians Clinic provided charity care of \$1,981,982 and unreimbursed medicaid charges of \$2,142,530 determined on a cost to charges ratio demonstrating its commitment to help those unable to afford healthcare for a variety of reasons. There were over 503,450 patient visits at 21 locations in Omaha and surrounding communities. In 2009, Methodist Physicians Clinic has taken an active role in a national cardiovascular education initiative known as HeartCaring. One of many unique program offerings available through the Spirit Health Group, HeartCaring focuses on educating primary care physicians on gender differentiation in cardiovascular care. These physicians, in turn, share with women throughout the community the knowledge they have gained with respect to the unique risk factors, early detection and appropriate treatment options associated with cardiovascular disease in women. In 2009, Methodist Physicians Clinic primary care physicians participated in HeartCaring training, the information from which was shared at community health fairs and in-clinic open houses. Physicians Clinic professionals generously give of their time and services to several area organizations that provide care to the uninsured and indigent in the Omaha area. Two of these organizations - Hope Medical Outreach and the Renaissance Health Clinic - characterize support from Methodist Physicians Clinic physicians as outstanding, with more than 20 different clinic physicians routinely accepting referred patients for further treatment. Key among those participating are family practitioners, surgeons, orthopedic surgeons and OB-Gyns.

	The Women's Center at Methodist Physicians Clinic participates in a number of different programs aimed at helping educate Omaha area women about the risks and warning signs associated with breast cancer. OB-GYN physicians from the Women's Center make presentations once or twice each month to groups interested in learning more about the experiences and recommendations of breast cancer survivors. Information about breast self-exams and cancer warning signs were distributed at various community events.
