For the current year the Organization believes all tax positions are fully supportable by existing Federal law and related interpretations and there are no uncertain tax positions to consider in accordance with FIN 48.
		Cost of goods sold and rental expenses both were netted against revenue on the Statement of Revenue on the 990 but were listed as expenses on the financial statements. This resulted in less revenue and also less expenses on the 990 compared to the financial statements.
