COMPENSATION MATERIAL, JOB DESCRIPTION AND GOALS. PERSONNEL COMMITTEE  
EVALUATES EXECUTIVE DIRECTOR AND DISCUSSES THEIR RECOMMENDATIONS WITH THE  
EXECUTIVE DIRECTOR. PERSONNEL COMMITTEE TAKES A RECOMMENDATION TO THE  
BOARD OF DIRECTORS AT A REGULARLY SCHEDULED MEETING FOR DISCUSSION AND  
APPROVAL.
