The Riley County Council on Aging provided 67.4% of the Center's funding; the remainder of its funding was raised by the Center. the City of Manhattan provides the building.**

**Mission: To provide safe, reliable, and affordable transportation to citizens of Manhattan and Riley County. Buses and minivans are equipped with ramps and lifts to accommodate the needs of the disabled. In 2009, ATA Bus provided 38,599 rides to 768 unduplicated individuals.**

**Mission: Funding provided by the Riley County Council on Aging was used in the Health Care Attendant Program, which involves providing assistance to clients in need of bathing, medication reminders, dressing, grooming, and toileting under the direction of a licensed health care professional. Volunteers provide assistance with light housekeeping duties, laundry, essential shopping errands, and meal preparation. For 2009, Homecare and Hospice Attendant Program provided 13,835 hours of services to 145 unduplicated individuals.**
