In 2009, 9,145 Aurora, CO residents were helped with emergency services. In its 41st year of operation, this organization maintained optimum relief efforts despite the recession. Aurora Interchurch Task Force, Inc. passed on to residents approximately \$561,489 in donated goods, such as bus tokens, groceries, clothing, and household items; utility, rental and prescription funds.

4,686 persons were provided groceries valued at \$161,771

2,103 persons were provided clothing valued at \$206,615

329 persons were provided household goods valued at \$21,675

1,028 persons were helped with utility payments totaling \$107,476

803 persons were helped with housing payments totaling \$60,320
