ISLANDS AND TRAILS WERE CONSTRUCTED ALONG WITH A BRIDGE, BOARDWALK, CULVERT, WILDLIFE OBSERVATION AREA, AND TRAIL ACCESS POINTS. THOSE BENEFITTING INCLUDE LOCAL RESIDENTS, TOURISTS TO THE COMMUNITY, SCHOOLS, CHURCHES, 4-H CLUB, SCOUTS, AND OTHER GROUPS WHO USE THE AREA FOR RECREATIONAL AND/OR EDUCATIONAL PURPOSES.
