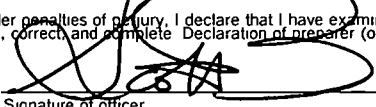
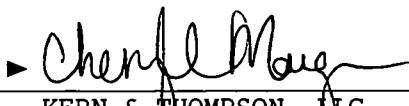

IN THE LAST YEAR, WE HAVE DIRECTLY REACHED OVER 1,500 AGRICULTURAL PROFESSIONALS AND FARMERS THROUGH TRAININGS, WORKSHOP, AND OTHER OUTREACH EVENTS. OUR WORK HAS NOW INCORPORATED POLLINATORS INTO AGRICULTURAL CONSERVATION PROGRAMS AND PROVIDED TECHNICAL ASSISTANCE AND TRAINING ACROSS THE UNITED STATES. THIS HAS LED TO THOUSANDS OF ACRES OF HABITAT IMPROVEMENTS FOR POLLINATORS.
