1 The Gardiner Library Association (GLA) requests abatement of any late filing penalties and interest thereon due to good faith
2 and reasonable cause. GLA is run by volunteers, no one is paid for management services. GLA has had an informal
3 accounting system that is no longer capable of meeting its accounting and reporting needs. GLA spent time to find an
4 accountant that could design their accounting system and process their transactions. As the GLA is run by volunteers, there
5 were many delays between meetings, requests for information and responses to requests. Further complicating matters
6 was a server crash. Much time was required to trace and identify the year's financial activity in order to prepare a complete
7 and accurate return. The GLA was formed to aid the provision of library services to Gardiner, Maine and the surrounding
8 communities. No member receives compensation or inurement. GLA did not willfully neglect, nor did it knowingly or
9 deliberately violate or ignore the requirements of the IRS's regulations. Penalizing the GLA would impose a hardship on the
10 organization and the penalty would be contrary to public policy encouraging public support for the provision of library services.
