

YES! YOUTH EDUCATION SUCCESS SUMMIT

The Youth Education Success Summit is an all day educational forum for middle and high school students in the Dallas / Fort Worth Texas area designed to help youth prepare for college. Students participate in small group discussions and interactive workshops. Topics include (1) College Credit for Cool Careers Starts in High School; (2) Financial Responsibility and Credit Management; (3) From College to Career: Resume Writing and Interview Tips; (4) Creative Essay Writing; (5) You Be the Judge: Understanding the Law; (6) Empowering Yourself with Leadership Skills (7) Living a Healthy Lifestyle and (8) Show Me the Money: Financial Aid and Scholarships. Students also receive a tour of a college campus, visit an onsite mobile center that gives instructions on applying for scholarships and financial aid, and hear testimonials from college students on successfully navigating freshman year. Exhibitors from local colleges and universities are also on site to distribute information about their schools.

SCHOOL TOOLS SCHOOL SUPPLY DRIVE

School supplies are donated to a local elementary school with predominantly minority students from low income families. School supplies are provided to two students per grade (pre-kindergarten through sixth grade). The students who received the supplies are selected by the school principal to ensure those with the greatest need are selected. COMMUNITY PARTNERS OF TARRANT COUNTY: RAINBOW ROOM

The Rainbow Row Room, a 501(c)(3) entity, is an on-site emergency pantry that serves the caseworkers and the abused and neglected children of Child Protective Services (CPS). It contains essential items such as food, clothing, shoes, infant formula, diapers, cleaning supplies, toys, safety items, port-a-cribs, bedding, and school supplies/uniforms etc. These items are made available free of charge to caseworkers working with needy children and families. The Xi Theta Omega Foundation, partnered with the Tarrant County Rainbow Room to provide shoes, underwear and socks for needy children.
