Publishes the annual Directory of Pathology Training Programs. In 2009, the 42nd edition had 745 pages which included information on 142 residency listings, 479 fellowships, and 9 post-sophomore listings. ICPI mailed out 1,500 copies of the book to Medical Libraries, Deans of Education, Chairs of Pathology Departments of Medical Schools. This book is available to the general public. ICPI maintains a website where the Directory information is available for free to the public.

A new addition of the Pathology as a Career in Medicine brochure was created and printed for distribution for all medical students in the United States. Print copies to the public are free. ICPI maintains a freely available version on its website.
