The National Military Family Association is the leading nonprofit organization committed to strengthen and protect the families of the men and women currently serving, retired, wounded, or fallen. We provide families of the Army, Navy, Marine Corps, Air Force, Coast Guard, and Commissioned Corps of the USPHS and NOAA with information, work to get them the benefits they deserve, and offer programs that improve their lives. Through our Outreach, Education, Civic Involvement, and Youth Initiatives efforts, we work individually and with others to promote and protect the interests of military families. Our 40 years of service and accomplishments have made us a trusted resource for military families and the Nation’s leaders. More than 200 Volunteers and Representatives located in communities worldwide contributed approximately 17,700 volunteer hours to our Association in 2009.

YOUTH INITIATIVES. The National Military Family Association sponsors "Operation Purple" (registered trademark), a free summer camp program for military children with a parent deployed in Iraq, Afghanistan, or other locations around the globe. "Operation Purple" summer camps give military kids an exciting and memorable camp experience, while enjoying the healing powers of the outdoors, being with other children who are going through the challenges of a parent's deployment, and learning additional tools to help them deal with deployment, and celebrating their own service. In 2009, we expanded the "Operation Purple" program to include family retreats held in the National Parks, focused on helping families reunite after a deployment create new family memories in a beautiful natural setting. We sponsored a week-long "Operation Purple Healing Adventures" family camp to help wounded service members reconnect with their children after their injuries and learn how to play again as a family.

COMMUNITY OUTREACH. The National Military Family Association reaches out to military communities and civilian supporters of military families to give them the tools to support service members and their families. We publish a "Military Spouse Education Resource Guide", a resource with education information specific to the military spouse, complementing the counseling services provided by military installation education centers and the schools attended by spouses. Our "Top 10 Things Military Teens Want You to Know" toolkit was developed based on input from military teens who attended our "Operation Purple" camps. The toolkit is designed for the caring adults in the civilian community: medical providers, educators, coaches, youth group leaders who interact with military children, but need information about what these children experience due to their parents' deployment and what resources are available to help. Our web surveys seek information from military families about issues important to their lives. Through our Joanne Holbrook Patton Scholarship Program, we offer scholarships to military spouses so they can begin, continue, or complete their higher education. Included among our scholarship recipients are spouses of wounded or fallen service members. Our Family Award Program recognizes military families that exemplify the best of the military lifestyle. In 2009, our Family Award recipients were recognized as part of our 40th Anniversary Celebration. This event highlighted our Association's long-term service to military families and provided the opportunity to inform military leaders and families about the programs and information we make available. We also call together senior military spouses from all Services and components to hear from them of the issues affecting the families they serve.

INFORMATION AND EDUCATION. The National Military Family Association reaches out to military families and communities to monitor the ever-changing military climate and how it affects military families. We offer support for families who have loved ones serving overseas, often in harm's way. Through our publications, our website, our worldwide Volunteer Corps, and our daily outreach to military families, we connect them with the information and support offered by our Association and by a variety of government agencies and private organizations. We make sure military families know about all of the educational opportunities available to wives, husbands, and children. We help military families navigate their health care options. Our publications (a bi-monthly newsletter, produced in electronic and hard copy formats, a weekly email news update, a monthly email bulletin, and monthly military spouse club email) help us disseminate information worldwide among military service members and their families, senior-level Department of Defense officials, Members of Congress and their staffs, military installation support staff, and Association members. We speak to various groups on topics of concern to military families: support for military children, the impact of deployment, spouse education and employment, National Guard and Reserve family issues. In 2009, we completed an upgrade to our website, with an emphasis on making it easier for families to find needed information and resources. Our website is a valuable resource to all military families, family support personnel, and others interested in military families.
